#### Magdalena Sepúlveda

Director, United Nations Research Institute for Social Development (UNRISD)

Magdalena Sepúlveda Carmona has been Director of UNRISD since November 2024. Previously, she was Executive Director of the Global Initiative for Economic, Social and Cultural Rights and Senior Research Associate at UNRISD. With 22 years of experience in poverty, development, and human rights, she held roles at the Netherlands Institute for Human Rights, Inter-American Court of Human Rights, and UN University for Peace. She was UN Special Rapporteur on Extreme Poverty (2008-2014) and served on high-level UN panels. She holds a Ph.D. in International Law and speaks English, French, and Spanish.



#### Kira Kruglikova

Director of Administration, United Nations Office at Geneva (UNOG)

Kira Kruglikova is the Director of the Division of Administration of the United Nations Office at Geneva. She serves as UNOG's Focal Point for Disability Inclusion and Project Executive for the Strategic Heritage Plan (SHP), a multi-year, \$835 million construction and renovation project. Her previous positions include Director of the Division of Conference Management, Chief of the Production and Support Service, Executive Officer and Administrative Officer. Before joining the United Nations, she was a Foreign Service Officer with the U.S. Department of State. Prior to her diplomatic service, she worked in manufacturing for a major pharmaceutical company in various locations in the United States.



#### Joël Gapany

Director, School of Social Work Fribourg (HETS-FR)

Joël Gapany has been director of the School of Social Work in Fribourg (HETS-FR) since May 1, 2016. In his public appearances, he regularly stresses the importance of social work, both as a professional field and as a discipline, for the development of a more just, egalitarian and inclusive society. Under his leadership, the HETS-FR has developed new areas of research and teaching, notably in the fields of sustainability and environmental justice, digitalization and socio-professional integration, with a special focus on vulnerable and marginalized populations. How to support a caring society and inclusion of persons with

In the last decade, the number of countries designing and implementing

care systems or programmes has increased, particularly in Latin Ameri-

ca. This trend has resulted from the pressure of feminist groups aiming

to reduce the amount of care and unpaid work that women undertake.

In the context of care systems, people with disabilities have been seen as

dependent and reliant on care, ignoring that persons with disability are au-

tonomous and not all people with disabilities need care or the same level

of care. Indeed, most care systems have not included a human rights per-

spective that would lead to a more nuanced understanding of the links be-

tween disability and care. This presentation will focus on care dependency

and autonomy, emphasizing that the inclusion of people with disabilities in

care systems should prioritize recognizing their autonomy, as well as their roles in receiving and providing care. Examples from countries in the global

Human Rights and Disability Advisor, United Nations High Commissioner for Human Rights (OHCHR)

Facundo Chávez Penillas is the Human Rights and Disability Advisor at the Office of the United Nations High Commissioner for Human Rights in Geneva, a position he has held since 2013. A trained lawyer, he completed graduate studies in business law and human rights law. Prior to joining the UN, Facundo worked in the Disability Department at the Ombudsperson Office in Buenos Aires, Argentina, and at a corporate law firm. He has also been actively involved with organizations representing persons with disabilities at national, regional, and international levels.

Currently, she is the President of the Thailand Association of Social Workers and a Regional Commissioner for the IFSW-AP at the UN. Her work focuses on counseling, disability, social work competency development, and education. Dr. Kotbungkair has received a Fulbright Fellowship at Vanderbilt University and the Outstanding Professional Social Worker Award from the Prakorn Foundation.
